<u>Presentation</u> Allen LaGrange and Ethan Brown presented staff work on water monitoring data for the Shasta River from this summer. Preliminary data shows a higher correlation between air temperature and water temperature than between water temperature and flows in 2022. Further discussion related to the questions posed last month: Did we gain any habitat for over-summering coho due to the increased flows? How far down river did the cool water make it? Where in the river was the lethal temperature zone (18 degrees Celsius) zone before the curtailment and in 2022? **INAL**

**10.1** Continued review and input on draft SVRCD Logo. Dowse led a discussion on further and possibly final suggested changes to the draft Logo.

#### **Staff and Project Reports**

Lascheck gave selected updates on the Forestry and Fire Prevention work. Of note was a Klamath TREX cultural resources prescribed burn focusing on basket weaving materials and other valuable plant materials that need fire. A full forestry report was provided to the Board.

Brown reported on his attendance at the IRWMP meeting in Ashland and opportunities for networking there. Future work focused on Klamath Dam removal will be a possibility for SVRCD. KBMP is coming to Yreka in November and SVRCD will present.

Perry provided some information on soil health grant possibilities and options for future work. This could bolster our work on climate resiliency and groundwater by providing agricultural producers practices and programs to improve water holding capacity and soil water infiltration. Composting and bio-char were mentioned, as well as soil health challenges on dryland and rangeland in our area.

**Agency Reports:** Patterson gave a report on his work with the federal fire recovery team, called Water Emergency Response Team (WERT).
